AN ORDINANCE
TO AMEND
CHAPTER 79

THE TOWNSHIP OF MAPLEWOOD
ENTITLED
"ALCOHOLIC BEVERAGES"

"Interpretive Statement"

This ordinance will add the Maplewood Memorial Library, Baker Street, as a Township property upon which alcoholic beverages may be distributed and consumed upon permission of the Maplewood Township Committee

WHEREAS, with permission of the Maplewood Township Committee, alcoholic beverages may be served within designated Township owned properties; and

WHEREAS, the Maplewood Memorial Library Board of Trustees has requested that the Maplewood Memorial Library, Baker Street, be added to the list of Township properties within which alcoholic beverages may be distributed and consumed.

NOW, THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Maplewood, County of Essex, State of New Jersey, that Chapter 79 of the Code of the Township of Maplewood entitled "Alcoholic Beverages" be amended as follows:

FIRST: ARTICLE I,
Consumption in Public Places: Section 79-1 B, be amended to read:

Notwithstanding anything contained herein to the contrary, the Township of Maplewood may, by resolution of the Maplewood Township Committee, as part of an approved use of the Burgdorff Cultural Center, 1978 Springfield Avenue or the Maplewood Memorial Library, Baker Street, permit the distribution and consumption of alcoholic beverages incidental to the approved use and upon securing any license required by law, including the Alcoholic Beverage Commission.

All other Sections shall remain unchanged.

SECOND: Severability

If any section, paragraph, subparagraph, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the specific section, paragraph, subparagraph, clause or provision so adjudged and the remainder of the Ordinance shall be deemed valid and effective.

THIRD: Repeal of Prior Ordinances

Ordinances or parts of Ordinances inconsistent with the provisions of this Ordinance be and the same are hereby repealed to the extent of any such inconsistencies.

FOURTH: Effective Date

This Ordinance shall take effect after final passage and publication and as provided by law.

PUBLIC NOTICE is hereby given that the foregoing proposed Ordinance was introduced and read by title for the first time at a meeting of the Township Committee of the Township of Maplewood, held on April 16, 2013, and that Committee met again on May 7, 2013, at 7:30 p.m. at the Municipal Building, 574 Valley Street, Maplewood, New Jersey, at which time and place the Committee proceeded to consider the said Ordinance on second reading and final passage.
