**AN ORDINANCE  
TO AMEND  
CHAPTER 257  
OF THE CODE OF THE TOWNSHIP OF MAPLEWOOD  
ENTITLED  
"Vehicles and Traffic"**

*"Interpretive Statement"*

*This ordinance will allow property owners on Villa Terrace certain on street parking privileges.*

**WHEREAS**, time limit parking is presently in effect on Village Terrace, both sides, 3 hours, 7:00 a.m. to 5:00 p.m. each day, from Valley Street to Raymond Terrace; and

**WHEREAS**, property owners on Villa Terrace have requested relief from this time limit parking; and

**WHEREAS**, the Maplewood Township Committee has agreed to grant the request of the residents of Villa Terrace.

**NOW, THEREFORE, BE IT ORDAINED**, by the Township Committee of the Township of Maplewood, County of Essex, State of New Jersey that Chapter 257 of the Code of the Township of Maplewood entitled "Vehicles and Traffic" be amended as follows:

**FIRST:**

**Section 257-53, shall be amended to read as follows:**

<b>Section 257-53:</b>		<b>Schedule XVII:</b>	<b>Time Limit Parking</b>
<u>Name of Street</u>	<u>Side</u>	<u>Time Limits; Hours/Days</u>	<u>Location</u>
Villa Terrace	Both	3 Hours 7:00 a.m. to 5:00 p.m./All	From Valley Street to Raymond Terrace

The foregoing limitations shall not apply to residents of Villa Terrace prominently displaying a permit issued by the Township of Maplewood.

Each property owner on Villa Terrace shall be entitled to one (1) parking permit, per dwelling unit, which shall be issued by the Township Clerk after receipt of a completed application. The permit shall be prominently displayed in the vehicle which is parked in the above described area.

**SECOND: Severability**

If any section, paragraph, subparagraph, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the specific section, paragraph, subparagraph, clause or provision so adjudged and the remainder of the Ordinance shall be deemed valid and effective.

**SECOND: Repeal of Prior Ordinances**

Ordinances or parts of Ordinances inconsistent with the provisions of this Ordinance be and the same are hereby repealed to the extent of any such inconsistencies.

**THIRD: Effective Date**

This Ordinance shall take effect after final passage and publication and as provided by law.

**PUBLIC NOTICE** is hereby given that the foregoing proposed Ordinance was introduced and read by title for the first time at a meeting of the Township Committee of the Township of Maplewood, held on August 6, 2013, and that Committee met again on September 3, 2013, at 7:30 p.m. at the Maplewood Police and Court Building, 1618 Springfield Avenue, Maplewood, New Jersey, at which time and place the Committee proceeded to consider the said Ordinance on second reading and final passage.
