AWARD OF CONTRACT MAPLEWOOD MEMORIAL LIBRARY WINDOW REPLACEMENT

WHEREAS, on Tuesday, January 28, 2014, sealed bids were received, opened and read for Maplewood Memorial Library Window Replacement in accordance with the plans and specifications; and

WHEREAS, the Township Engineer has recorded the summary of the results described herein as:

WHEREAS, the Township Design Consultant has reviewed and approved the bid of Panoramic Window & Door Systems; and

WHEREAS, the Township Attorney has reviewed and approved the bid of Panoramic Window & Door Systems; and

WHEREAS, the Chief Financial Officer has certified that funds are available for this purpose.
