RESOLUTION AWARDING CONTRACT FOR FURNISHING AND DELIVERING POOL CHEMICALS FOR MAPLEWOOD COMMUNITY POOL FOR 2014

WHEREAS, the Township of Maplewood (“Township”) awarded a contract for the furnishing and delivery of pool chemicals to Universal Chemicals, Inc., for the Maplewood Community Pool for 2013 in the amount of \$24,163.20; and

WHEREAS, the Director of Recreation and Cultural Affairs Department has recommended an extension of the contract with Universal Chemicals, Inc., for 2014, as the performance of Universal Chemicals, Inc., was effective and efficient; and

WHEREAS, an extension of the Contract with Universal Chemicals, Inc., is permitted pursuant to N.J.S.A.40A:11-15; and

WHEREAS, the Chief Financial Officer has certified that funds are available.

NOW, THEREFORE BE IT RESOLVED, by the Township Committee of the Township of Maplewood, County of Essex, State of New Jersey that:

1. A contract be awarded to Universal Chemicals, Inc., in the amount of \$24,163.20 for the furnishing of pool chemicals to the Maplewood Community Pool for 2014, upon the same terms and conditions as set forth in the 2013 contract; and
2. The Township Administrator and the Township Clerk be and are hereby authorized to enter into a contract on behalf of the Township of Maplewood consistent with the intent of this resolution.


Thank you for the opportunity to supply the Township Municipal Swimming Pool again for this coming 2014 season. I greatly appreciate that you were satisfied with our service.
