### **AWARD OF CONTRACT MAPLECREST PARK PATH RENOVATIONS**

**WHEREAS**, on Tuesday, March 25, 2014, sealed bids were received, opened and read for Maplecrest Park Path Renovations in accordance with the plans and specifications; and

**WHEREAS**, the Township Engineer has recorded the summary of the results described herein as :
