

# TOWNSHIP OF MAPLEWOOD



## ORDINANCE # 2752-14

### AN ORDINANCE TO AMEND CHAPTER 257 OF THE CODE OF THE TOWNSHIP OF MAPLEWOOD ENTITLED "VEHICLES AND TRAFFIC"

*This ordinance will change parking times along Durand Road.*

**WHEREAS**, the Maplewood Village Alliance has asked the Maplewood Township Committee to evaluate the need for short term parking; and

**WHEREAS**; there is a no longer a need for short term parking on Durand Road and

**WHEREAS**; short term parking on Durand Road is to be made consistent with the parking in Ricalton Square and

**WHEREAS**, there is also a typographical error in the Township Ordinance related to parking on Durand Road; and

**WHEREAS** these changes have been reviewed and accepted by the Planning and Engineering Committee, and

**NOW THEREFORE, BE IT ORDAINED** by the Township Committee of the Township of Maplewood, in the County of Essex and State of New Jersey that Chapter 257 of the Code of the Township of Maplewood entitled "**Vehicles and Traffic, Article VI: Schedules**" be amended as follows:

**FIRST:** Section 257-51 – Schedule XV: Parking Prohibited Between Certain Times on Certain Streets is deleted as follows:

<u>Name of Street</u>	<u>Side</u>	<u>Hours/Days</u>	<u>Location</u>
Durand Road	South	6:00 a.m. to 9:00 p.m./Monday to Friday	From Ridgewood Road to Woodland Road

**SECOND:** Section 257-53 – Schedule XVII: Time Limit Parking is deleted as follows:

<u>Name of Street</u>	<u>Side</u>	<u>Time Limit;</u> <u>Hours/Days</u>	<u>Location</u>
Durand Road	North	20 mins.; 9:00 a.m. to 4:00 p.m./All except Sunday	From a point 29 feet east of Maplewood Avenue to a point 42 feet east thereof

**THIRD:** Section 257-51 – Schedule XV: Parking Prohibited Between Certain Times on Certain Streets is added as follows:

<u>Name of Street</u>	<u>Side</u>	<u>Hours/Days</u>	<u>Location</u>
Durand Road	South	6:00 a.m. to 9:00 a.m./Monday to Friday	From Ridgewood Road to Woodland Road

**FOURTH:** Section 257-53 – Schedule XVII: Time Limit Parking is added as follows:

<u>Name of Street</u>	<u>Side</u>	<u>Time Limit;</u> <u>Hours/Days</u>	<u>Location</u>
Durand Road	North	2 hrs.; 9:00 a.m. to 7:00 p.m./All except Sunday	From a point 29 feet east of Maplewood Avenue to a point 42 feet east thereof

**FIFTH:** If any section, paragraph, subparagraph, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the specific section, paragraph, subparagraph, clause or provision so adjudged and the remainder of the Ordinance shall be deemed valid and effective.

**SIXTH:** Whole Ordinances or parts of Ordinances inconsistent with provisions of this Ordinance are hereby repealed.

**SEVENTH:** This Ordinance shall take effect on final passage and publication according to law.

**PUBLIC NOTICE** is hereby given that the foregoing proposed Ordinance was introduced and read by title for the first time at a meeting of the Township Committee of the Township of Maplewood, held June 17, 2014 and that the Committee met again on July 1, 2014 at 7:30 p.m. at the Police/Municipal Court Building, 1618 Springfield Avenue, Maplewood, New Jersey, at which time and place the Committee proceeded to consider said Ordinance on second reading and final passage.
