

# TOWNSHIP OF MAPLEWOOD



**ORDINANCE #2758-14**

## AN ORDINANCE TO AMEND CHAPTER 257 OF THE CODE OF THE TOWNSHIP OF MAPLEWOOD ENTITLED "VEHICLES AND TRAFFIC"

*This ordinance will change parking times along Dunnell Road and Baker Street.*

**WHEREAS**, there is are several typographical errors and redundancies in the Township Ordinance related to parking on *Dunnell Road and Baker Street* which require changes; and

**WHEREAS** these changes have been reviewed and accepted by the Planning and Engineering Committee, and

**NOW THEREFORE, BE IT ORDAINED** by the Township Committee of the Township of Maplewood, in the County of Essex and State of New Jersey that Chapter 257 of the Code of the Township of Maplewood entitled "**Vehicles and Traffic, Article VI: Schedules**" be amended as follows:

**FIRST:** Section 257-53 – Schedule XVII: Time Limit Parking is deleted as follows:

<u>Name of Street</u>	<u>Side</u>	<u>Hours/Days</u>	<u>Location</u>
Baker St.	South	15 mins.: All/All	From the east side of Dunnell Road to a point 160 feet east thereof

**SECOND:** Section 257-61 – Schedule XXV: Permit Parking is deleted as follows:

<u>Name of Street</u>	<u>Side</u>	<u>Time Limit; Hours/Days</u>	<u>Location</u>
Dunnell Road [Added 5-21-2002 by Ord. No. 2188-02]	West	6:00 a.m. to 9:00 a.m./Monday to Friday except holidays	From a point 993 feet north of Baker Street to a point 28 feet north thereof
Dunnell Road	West	6:00 a.m. to 9:00 a.m./Monday to Friday except holidays	From a point 1,155 feet north of Baker Street to a point 108 feet north thereof

**THIRD:** Section 257-56 – Schedule XX: Handicapped Parking is deleted as follows:

<u>Location</u>	<u>Number of Spaces</u>
DeHart Park/Maplewood Community Center Lot	1
Dunnell Road at Police Headquarters	1

**FOURTH:** Section 257-56 – Schedule XX: Handicapped Parking is added as follows:

<u>Location</u>	<u>Number of Spaces</u>
DeHart Park/Maplewood Community Center Lot	3
Dunnell Road at Civic House	1

**FIFTH:** If any section, paragraph, subparagraph, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the specific section, paragraph, subparagraph, clause or provision so adjudged and the remainder of the Ordinance shall be deemed valid and effective.

**SIXTH:** Whole Ordinances or parts of Ordinances inconsistent with provisions of this Ordinance are hereby repealed.

**SEVENTH:** This Ordinance shall take effect on final passage and publication according to law.

**PUBLIC NOTICE** is hereby given that the foregoing proposed Ordinance was introduced and read by title for the first time at a meeting of the Township Committee of the Township of Maplewood, held September 2, 2014 and that the Committee met again on September 16, 2014 at 7:30 p.m. at the Police/Municipal Court Building, 1618 Springfield Avenue, Maplewood, New Jersey, at which time and place the Committee proceeded to consider said Ordinance on second reading and final passage.
