**AN ORDINANCE
TO AMEND
CHAPTER 257
OF THE CODE
OF THE TOWNSHIP OF MAPLEWOOD
ENTITLED
"VEHICLES AND TRAFFIC"**

"Interpretive Statement"

This ordinance will establish 20 minute parking on Maplewood Avenue in the area of 195 Maplewood Avenue, the new post office location, and create a limited time loading zone on Maplewood Avenue in front of 195 Maplewood Avenue, for post office delivery and pick-up.

BE IT ORDAINED, by the Township Committee of the Township of Maplewood, County of Essex, State of New Jersey, that Chapter 257 of the Code of the Township of Maplewood entitled "Vehicles and Traffic" be amended as follows:

All other sections shall remain the same.

SECOND: Severability

If any section, paragraph, subparagraph, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the specific section, paragraph, subparagraph, clause or provision so adjudged and the remainder of the Ordinance shall be deemed valid and effective.

THIRD: Repeal of Prior Ordinances

Ordinances or parts of Ordinances inconsistent with the provisions of this Ordinance be and the same are hereby repealed to the extent of any such inconsistencies.

FOURTH: Effective Date

This Ordinance shall take effect after final passage and publication and as provided by law.

PUBLIC NOTICE is hereby given that the foregoing proposed Ordinance was introduced and read by title for the first time at a meeting of the Township Committee of the Township of Maplewood, held on November 17, 2014, and that Committee met again on December 2, 2014, at 7:30 p.m. at the Municipal Building, 574 Valley Street, Maplewood, New Jersey, at which time and place the Committee proceeded to consider the said Ordinance on second reading and final passage.
