## RESOLUTION NO. 228-14

### RESOLUTION ESTABLISHING THE RATE FOR OFF DUTY MAPLEWOOD POLICE OFFICERS

WHEREAS, the Township of Maplewood ("Township") permits the hiring of off duty Maplewood police officers to provide traffic safety; and

WHEREAS, from time to time it is necessary to establish the hourly rate for off duty police officers; and

WHEREAS, the Maplewood Police Chief in conjunction with the Maplewood PBA has recommended an hourly rate for off duty police officer; and

WHEREAS, the Township Committee previously passed Resolution #66-14; and

WHEREAS, the Township Committee has been requested to amend Resolution #66-14.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Maplewood, County of Essex, State of New Jersey that:

1. The hourly rate for off duty police officers effective January 1, 2014, is \$85.82 per hour, of which \$78.02 shall be the hourly rate for the police officer, plus \$7.80 shall be the hourly Administrative Fee;
2. The hourly rate for a "Community Outreach Officer" for the Maplewood South Orange Alliance effective January 1, 2014 is \$41.66 per hour.
3. The hourly rate for off duty police officers effective January 1, 2014 for the South Orange Maplewood Board of Education and for Funeral Services is \$33.00 per hour, of which \$30.00, shall be the hourly rate for the police officer, plus \$3.00 shall be the hourly Administrative Fee;
4. In addition to the above, if the police administration determines that a marked police vehicle should be assigned to the off duty job, the costs shall be \$12.00 per hour;
5. All off duty assignments will be governed by Maplewood Police Department standard operating procedures and all other applicable procedures in effect as approved by the Maplewood Police Chief and shall be at rates between \$33.00 per hour and \$85.82 per hour and shall be subject to ten (10%) percent per hour Administrative Fee; and

6. The aforementioned rates shall remain in effect pending further determination by the Maplewood Township Committee.
