RESOLUTION NO. 230-14

AUTHORIZING PURCHASE AND ONSITE DELIVERY OF CONCRETE SKATE ELEMENTS UNDER THE NEW JERSEY STATE CONTRACT

WHEREAS, the Maplewood Township Committee authorized the use of certain NJ Department of the Treasury vendors pursuant to the provisions of NJAC 5:34-7.21; and

WHEREAS, Spohn Ranch, Inc. is an authorized vendor under the State Contract No.A81435 for purposes of supplying Concrete Skate Elements; and

WHEREAS, the work to be performed by Spohn Ranch, Inc. is within the costs projected by the Township Engineering Department; and

WHEREAS, the Chief Financial Officer has certified that funds are available for this purpose; and

WHEREAS, the provisions of N.J.S.A. 40 A:11-11 permit the award of a contract to Spohn Ranch, Inc. without the necessity of competitive bidding by the Township of Maplewood.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Maplewood, County of Essex, State of New Jersey, that the Township of Maplewood;
