

TOWNSHIP OF MAPLEWOOD

RESOLUTION NUMBER 61-15

BE IT RESOLVED, that application having been made to the Township Committee of the Township of Maplewood to transfer to Wine Barrel Maplewood, LLC, as a POCKET LICENSE until a location can be named, for Plenary Retail Distribution License Number 0711-44-010-006, hereto issued to Kukreja Corporation, t/a Boyden Pantry, and said applicant having in all respects complied with the requirements of the Statutes of the State of New Jersey and Ordinances of the municipality essential to the transfer of such license and said applicant having submitted a sworn statement affirming that he will assume all outstanding obligations of the transferor, the Township Clerk of the Township of Maplewood is hereby authorized and directed as agent of the Township Committee, to transfer on behalf of the Township Committee, Plenary Retail Distribution License Number 0711-44-010-006 issued to Kukreja Corporation, t/a Boyden Pantry to Wine Barrel Maplewood, LLC, as approved by the Maplewood Police Department.

The foregoing license is to become effective March 3, 2015 and the license will expire on June 30, 2015.

The following shall be adhered to: (once location is named and in operation)


1. Licensee will voluntarily post signs/notices at their cash registers which will advise customers that consumption of alcoholic beverages on the streets of Maplewood is forbidden by Township Ordinance. The Township Clerk will provide the signs/notices to be posted.
2. Licensee will not offer straws or extra paper bags to their customers.
3. Licensee will not offer free cups to customers.
4. Licensee will not "ice down" 50 ml., 100ml., or 200 ml. bottles of liquor or individual cans of beer.
5. Licensee agrees to maintain the areas in and about their store and keep it free from debris.
6. No liquor may be sold in any container commonly called a miniature.
7. No beer may be sold in a single quart sized container.

8. Maplewood will continue to enforce the Ordinances involved and work with the Licensee regarding any complaints they have.
9. Licensee pledges to cooperate with Maplewood and agrees to institute the voluntary measures described hereinabove.

This license is subject to the rules and regulations heretofore or hereafter adopted by the Governing Body as well as by all other lawful authority as well as to all the Statues of this State and Federal Government in such cases made and provided.
