ORDINANCE # 2775-15

AN ORDINANCE TO AMEND CHAPTER 257 OF THE CODE OF THE TOWNSHIP OF MAPLEWOOD ENTITLED "VEHICLES AND TRAFFIC"

This ordinance will correct errors in existing ordinances regarding left hand turns.

WHEREAS, there are restrictions on left turns in several locations in the Township; and

WHEREAS, the regulations in the area have been superseded; and

WHEREAS these changes have been reviewed and accepted by the Planning and Engineering Committee, and

NOW THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Maplewood, in the County of Essex and State of New Jersey that Chapter 257 of the Code of the Township of Maplewood entitled "**Vehicles and Traffic, Article VI: Schedules**" be amended as follows:

FIRST: Section 257-41 – Schedule V: Prohibited Turns at Intersections is deleted as follows:

Name of Street	Direction of Travel	Prohibited Turn	Hours	At Intersection of
Boyden Avenue	North	Left	4:00 p.m. to 6:00 p.m.	Springfield Avenue
Boyden Avenue	South	Left	4:00 p.m. to 6:00 p.m.	Springfield Avenue
Jacoby Street	North	Left	4:00 p.m. to 6:00 p.m.	Springfield Avenue

SECOND: Section 257-41 – Schedule V: Prohibited Turns at Intersections is added as follows:

Name of Street	Direction of Travel	Prohibited Turn	Hours	At Intersection of
Jacoby Street	North	Left	All	Springfield Avenue

THIRD: If any section, paragraph, subparagraph, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the specific section, paragraph, subparagraph, clause or provision so adjudged and the remainder of the Ordinance shall be deemed valid and effective.

FOURTH: Whole Ordinances or parts of Ordinances inconsistent with provisions of this Ordinance are hereby repealed.

FIFTH: This Ordinance shall take effect on final passage and publication according to law.

PUBLIC NOTICE is hereby given that the foregoing proposed Ordinance was introduced and read by title for the first time at a meeting of the Township Committee of the Township of Maplewood, held March 3, 2015 and that the Committee met again on March 17, 2015 at 7:30 p.m. at the Maplewood Municipal Building, 574 Valley Street, Maplewood, New Jersey, at which time and place the Committee proceeded to consider said Ordinance on second reading and final passage.
