## ORDINANCE # 2785-15

### AN ORDINANCE TO AMEND CHAPTER 257 OF THE CODE OF THE TOWNSHIP OF MAPLEWOOD ENTITLED "VEHICLES AND TRAFFIC"

#### *Interpretive Statement*

*This ordinance will provide for additional Time Limit Parking on Springfield Avenue.*

**WHEREAS**, there is a need for additional parking on Springfield Avenue; and

**WHEREAS**, the conditions have changed that affect the regulations in the area; and

**WHEREAS**, these changes have made it possible to provide for additional parking spaces; and

**WHEREAS** these changes have been reviewed and accepted by the Planning and Engineering Committee, and

**NOW THEREFORE, BE IT ORDAINED** by the Township Committee of the Township of Maplewood, in the County of Essex and State of New Jersey that Chapter 257 of the Code of the Township of Maplewood entitled "**Vehicles and Traffic, Article VI: Schedules**" be amended as follows:

**FIRST:** Section 257-53 – Schedule XVII: Time Limit Parking is deleted as follows:

<u>Name of Street</u>	<u>Side</u>	<u>Time Limit:</u> <u>Hours/Days</u>	<u>Location</u>
Springfield Avenue [Added 8-3-2010 by Ord. No. 2638-10]	North	2 hrs.; 8:00 a.m. to 6:00 p.m./All except Sunday	From a point 380 feet east of Tuscan Road to a point 260 feet west of Boyden Parkway

**SECOND:** 257-53 – Schedule XVII: Time Limit Parking is added as follows:

<u>Name of Street</u>	<u>Side</u>	<u>Time Limit:</u> <u>Hours/Days</u>	<u>Location</u>
Springfield Avenue	North	2 hrs.; 8:00 a.m. to 6:00 p.m./All except Sunday	From a point 380 feet east of Tuscan Road to a point 70 feet west of Boyden Parkway

**THIRD:** If any section, paragraph, subparagraph, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the specific section, paragraph, subparagraph, clause or provision so adjudged and the remainder of the Ordinance shall be deemed valid and effective.

**FOURTH:** Whole Ordinances or parts of Ordinances inconsistent with provisions of this Ordinance are hereby repealed.

**FIFTH:** This Ordinance shall take effect on final passage and publication according to law.

**PUBLIC NOTICE** is hereby given that the foregoing proposed Ordinance was introduced and read by title for the first time at a meeting of the Township Committee of the Township of Maplewood, held April 21, 2015 and that the Committee met again on May 5, 2015 at 7:30 p.m. at the Maplewood Municipal Building, 574 Valley Street, Maplewood, New Jersey, at which time and place the Committee proceeded to consider said Ordinance on second reading and final passage.
