### **INSERTION OF SPECIAL ITEM OF REVENUE AND APPROPRIATION IN THE 2015 MUNICIPAL BUDGET**

**WHEREAS**, NJSA 40A:4-87 provides that the Director of the Division of Local Government Services may approve the insertion of any special item of revenue in the budget of any municipality when such item shall have been made available by law and the amount thereof was not determined at the time of the adoption of the budget, and;

**WHEREAS**, said Director may also approve the insertion of an item of appropriation for an equal amount, and;

**WHEREAS**, the Township has been awarded \$247,500 from the State of New Jersey, Department of Transportation, *Municipal Aid Program for Springfield Ave. section 12*, and wishes to amend its 2015 budget to include this amount as a revenue;

**NOW, THEREFORE, BE IT RESOLVED** that the Township Committee of Maplewood hereby requests the Director of the Division of Local Government Services to approve the insertion of an item of revenue in the 2015 budget in the sum of \$247,500, which is now available as a revenue from the New Jersey, Department of Transportation, *Municipal Aid Program for Springfield Ave. section 12*, in the indicated amount, and;

**BE IT FURTHER RESOLVED** that a like sum of \$247,500 be and is hereby appropriated under the caption *NJ DOT-Springfield Ave. section 12*.
