FY 2015 STORM DRAINAGE IMPROVEMENTS

WHEREAS, on Tuesday, April 21, 2015, sealed bids were received, opened and read for FY 2015 Storm Drainage Improvements in accordance with the plans and specifications; and

WHEREAS, the Township Engineer has recorded the summary of the results described herein as:
