### **INSERTION OF SPECIAL ITEM OF REVENUE AND APPROPRIATION IN THE 2015 MUNICIPAL BUDGET**

#### **(ESSEX COUNTY RECREATION AND OPEN SPACE TRUST FUND-LOCAL AID PROGRAM)**

**WHEREAS**, NJSA 40A:4-87 provides that the Director of the Division of Local Government Services may approve the insertion of any special item of revenue in the budget of any municipality when such item shall have been made available by law and the amount thereof was not determined at the time of the adoption of the budget, and;

**WHEREAS**, said Director may also approve the insertion of an item of appropriation for an equal amount, and;

**WHEREAS**, the Township has been awarded \$150,000 from the Essex County Recreation and Open Space Trust Fund-*Local Aid Program*, and wishes to amend its 2015 budget to include this amount as a revenue;

**NOW, THEREFORE, BE IT RESOLVED** that the Township Committee of Maplewood hereby requests the Director of the Division of Local Government Services to approve the insertion of an item of revenue in the 2015 budget in the sum of \$150,000, which is now available as a revenue from the Essex County Recreation and Open Space Trust Fund-*Local Aid Program*, in the indicated amount, and;

**BE IT FURTHER RESOLVED** that a like sum of \$150,000 be and is hereby appropriated under the caption *Essex County Recreation and Open Space Trust Fund-Local Aid Program*.

Congratulations! I am pleased to announce that your municipality has received a grant award of \$150,000.00 from the Essex County Recreation and Open Space Trust Fund 2014 Local Aid Program.

This year's program was open exclusively to all municipalities within Essex County. In total, \$3.3 million was awarded to the 22 municipalities within Essex County. Projects ranged from open space acquisition to multi-park improvement projects and pool enhancements. Awards from the 2014 program do not require a match. However, all projects must be completed by June 1, 2015. All completed projects require certification from the municipal engineer that all criteria set forth in the application are being met.


