**SECTION IV: If any section, paragraph, subparagraph, clause or provision of the ordinance shall be judged invalid, such adjudication shall apply only to the specific paragraph, subparagraph, clause or provision so adjudged and the remainder of the ordinance shall be deemed valid and effective.**

**SECTION V. All ordinances or parts of ordinances not consistent with the provisions of this ordinance are hereby repealed.**

**SECTION VI: This ordinance shall take effect after final passage and publication in accordance with law**
