ORDINANCE # 2791-15

AN ORDINANCE TO AMEND CHAPTER 257 OF THE CODE OF THE TOWNSHIP OF MAPLEWOOD ENTITLED "VEHICLES AND TRAFFIC"

Interpretive Statement

This ordinance will provide for additional Parking on Boyden Avenue.

WHEREAS, there is a need for additional parking on Boyden Avenue; and

WHEREAS, the parking spaces were eliminated in 2007; and

WHEREAS, the street will be restriped in this area; and

WHEREAS, these striping changes have made it possible to provide for additional parking spaces; and

WHEREAS these changes have been reviewed and accepted by the Planning and Engineering Committee, and

NOW THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Maplewood, in the County of Essex and State of New Jersey that Chapter 257 of the Code of the Township of Maplewood entitled "**Vehicles and Traffic, Article VI: Schedules**" be amended as follows:

FIRST: Section 257-50 – Schedule XIV: No Stopping or Standing is deleted as follows:

<u>Name of Street</u>	<u>Side</u>	<u>Location</u>
Boyden Avenue [Added 8-7-2007 by Ord. No. 2418-07]	West	From Irvington Avenue to Ball Terrace

SECOND: 257-50 - Schedule XIV: No Stopping or Standing is added as follows:

<u>Name of Street</u>	<u>Side</u>	<u>Location</u>
Boyden Avenue	West	From Irvington Avenue to a point 150 feet south thereof
Boyden Avenue	West	From a point 35 feet north of Garfield Place to a point 35 feet south of Garfield Place
Boyden Avenue	West	From a point 200 feet north of Parker Avenue to Ball Terrace

THIRD: If any section, paragraph, subparagraph, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the specific section, paragraph, subparagraph, clause or provision so adjudged and the remainder of the Ordinance shall be deemed valid and effective.

FOURTH: Whole Ordinances or parts of Ordinances inconsistent with provisions of this Ordinance are hereby repealed.

FIFTH: This Ordinance shall take effect on final passage and publication according to law.

PUBLIC NOTICE is hereby given that the foregoing proposed Ordinance was introduced and read by title for the first time at a meeting of the Township Committee of the Township of Maplewood, held June 16, 2015 at the Police/Municipal Court Building, 1618 Springfield Avenue, Maplewood, New Jersey and that the Committee met again on July 7, 2015 at 7:30 p.m. at the Police/Municipal Court Building, 1618 Springfield Avenue, Maplewood, New Jersey, at which time and place the Committee proceeded to consider said Ordinance on second reading and final passage.
