WHEREAS, the Director of Public Works has recommended an award of contract to Cerbo's Parsippany Greenhouses, Inc.; and

WHEREAS, the Chief Financial Officer has certified that funds are available.

2. The Township Administrator and the Township Clerk be and are hereby authorized to execute all documents to implement the intent of this Resolution.
