**RESOLUTION
AUTHORIZING
THE SALE OF PERSONAL PROPERTY
NO LONGER NEEDED
FOR PUBLIC USE BY WAY OF AN
ON-LINE AUCTION WEBSITE**

WHEREAS, the Maplewood Memorial Library and the Township of Maplewood ("Township") have determined that the property described in Schedule A, attached hereto and incorporated herein, is no longer needed for public use; and

WHEREAS, the Local Unit Technology Pilot Program and Study Act ("P.L.2001, c.30) authorized the sale of surplus personal property no longer needed for public use through the use of an on-line auction service; and

WHEREAS, the Township intends to utilize the on-line auction services of GovDeals, Inc. located at 5907 Carmichael Place, Montgomery, Alabama 36117; and

WHEREAS, GovDeals, Inc. is a vendor that has a State contract to offer on-line services and regularly reports sales information to the Division of Local Government Services; and

WHEREAS, GovDeals, Inc.'s website address is www.govdeals.com; and

WHEREAS, the sale is being conducted pursuant to the Division of Local Government Services' Local Finance Notice 2008-9; and

WHEREAS, the terms and conditions of the agreement between the Township and GovDeals, Inc. are available on GovDeals, Inc.'s website and at the office of the Township Clerk.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Maplewood, County of Essex, State of New Jersey that:

- 1) The Township be and is hereby authorized to sell the surplus personal

property as indicated on Schedule A by way of the on-line auction website of GovDeals, Inc.;

- 2) The terms and conditions of the agreement between GovDeals, Inc. and the Township of Maplewood are available at www.govdeals.com and at the office of the Township Clerk;
- 3) All other provisions of N.J.S.A. 40A:12-13, *et seq.* shall apply;
- 4) The sale of the surplus property shall be sold in an "as is" condition without express or implied warranties;
- 5) The Township reserves the right to accept or reject any bid submitted.
