**AN ORDINANCE  
TO AMEND  
CHAPTER 123  
OF THE CODE OF THE TOWNSHIP OF MAPLEWOOD**

*"Interpretive Statement"*

*This ordinance will adjust the fees for the Maplewood Community Pool.*

WHEREAS, the Maplewood Pool Advisory Committee in conjunction with the Maplewood Department of Recreation, Parks and Cultural Affairs has recommended certain changes to the fees for the Maplewood Municipal Pool; and

WHEREAS, a presentation was made to the Maplewood Township Committee on February 15, 2011, by the Director of Maplewood Department of Recreation, Parks and Cultural Affairs.

NOW, THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Maplewood, County of Essex, State of New Jersey as follows:

**FIRST:**

**Chapter 193 Parks and Recreation Areas**

A. Article II, Maplewood Community Pool.

(1) Schedule of Fees shall be amended to read as follows:

Membership Category	3/15 - 4/30	5/1 - 7/31	After 8/1
Individual	\$145	\$185	\$80
Senior Citizen 65 and Older	\$115	\$155	\$65
College Student (18 to 23)	\$115	\$155	\$65

Youth (3-17)	\$5
Youth Book (5 passes)	\$25

**SECOND:**

**Severability**

If any section, paragraph, subparagraph, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the specific section, paragraph, subparagraph, clause or provision so adjudged and the remainder of the Ordinance shall be deemed valid and effective.

**THIRD:**

**Repeal of Prior Ordinances**

Ordinances or parts of Ordinances inconsistent with the provisions of this Ordinance be and the same are hereby repealed to the extent of any such inconsistencies.

<sup>1</sup>Couple category consists of either two (2) cohabitating adults or an adult and child under the age of eighteen (18) .

<sup>2</sup>Family categories are made up of two (2) adults and their custodial children.

<sup>3</sup>Family and Caregiver is made up of two (2) adults, one (1) caregiver and custodial children.

**FOURTH:**

**Effective Date**

This Ordinance shall take effect after final passage and publication and as provided by law.

**PUBLIC NOTICE** is hereby given that the foregoing proposed Ordinance was introduced and read by title for the first time at a meeting of the Township Committee of the Township of Maplewood, held on March 1, 2011, and that Committee met again on March 15, 2011, at 7:30 p.m. at the Municipal Building, 574 Valley Street, Maplewood, New Jersey, at which time and place the Committee proceeded to consider the said Ordinance on second reading and final passage.
