**AN ORDINANCE
TO AMEND
CHAPTER 123
OF THE CODE OF THE TOWNSHIP OF MAPLEWOOD
ENTITLED
"FEES"
(Municipal Pool)**

"Interpretive Statement"

This ordinance will set the fees for the Maplewood Municipal Pool Usage.

WHEREAS, at its meeting on January 12, 2012, the Maplewood Swimming Pool Advisory Committee (the "Committee") voted to recommend that membership fees be increased across each membership category; and

WHEREAS, the Committee recommended that membership remain open to only Maplewood residents; and

WHEREAS, membership fees are being increased to cover debt service associated with the one million (\$1,000,000.00) dollar plus improvements being made to the pool and in anticipation of pool operating costs.

NOW, THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Maplewood, County of Essex, State of New Jersey that Chapter 123 of Code of the Township of Maplewood entitled "Fees" be amended to change the usage fees for the Maplewood Municipal Pool as follows:

FIRST:

Chapter 193 Parks and Recreation Areas

A. Article II, Maplewood Community Pool.

(1) Schedule of Fees shall be amended to read as follows:

Guest Passes:

Adult	\$10
Adult Book (5 Passes)	\$40
Youth (3-17)	\$5
Youth Book (5 passes)	\$25

SECOND:

Severability

If any section, paragraph, subparagraph, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the specific section, paragraph, subparagraph, clause or provision so adjudged and the remainder of the Ordinance shall be deemed valid and effective.

¹Couple category consists of either two (2) cohabitating adults or an adult and child under the age of eighteen (18) .

²Family categories are made up of two (2) adults and their custodial children.

³Family and Caregiver is made up of two (2) adults, one (1) caregiver and custodial children.

THIRD:

Repeal of Prior Ordinances

Ordinances or parts of Ordinances inconsistent with the provisions of this Ordinance be and the same are hereby repealed to the extent of any such inconsistencies.

FOURTH:

Effective Date

This Ordinance shall take effect after final passage and publication and as provided by law.

PUBLIC NOTICE is hereby given that the foregoing proposed Ordinance was introduced and read by title for the first time at a meeting of the Township Committee of the Township of Maplewood, held on February 7, 2012, and that Committee met again on February 21, 2012, at 7:30 p.m. at the Municipal Building, 574 Valley Street, Maplewood, New Jersey, at which time and place the Committee proceeded to consider the said Ordinance on second reading and final passage.
