AN ORDINANCE
TO AMEND
CHAPTER 49
OF THE CODE OF THE TOWNSHIP OF MAPLEWOOD
ENTITLED
"POOL ADVISORY COMMITTEE"

"Interpretive Statement"

This ordinance will specify that the Maplewood Township Committee Members and Maplewood Township Employees who are members of this committee will be non-voting members of this committee.

BE IT ORDAINED, by the Township Committee of the Township of Maplewood, County of Essex, State of New Jersey, that Section 49-3 of the Code of the Township of Maplewood entitled "Pool Advisory Committee/Membership and term of office" shall be amended to read as follows:

FIRST: Section 49-3. Membership and term of office.

- A. The Township Committee shall appoint fifteen (15) residents of the Township of Maplewood to serve as the Pool Advisory Committee. The term of office shall be three (3) years unless otherwise indicated. All terms shall expire December 31 of the last year of the appointee=s term. The initial appointments shall be designated as follows:
- (1) Five (5) three-year terms.
 - (2) Five (5) two-year terms.
 - (3) Five (5) one-year terms.
- B. The Director of the Recreation, Parks & Cultural Affairs of the Township of Maplewood shall serve on the Pool Advisory Committee (ex officio), and as a non-voting member.
- C. The Township Committee liaison to this Committee shall be non-voting.

SECOND:

All other sections of Chapter 49-3 shall remain unchanged.

THIRD: Severability

If any section, paragraph, subparagraph, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the specific section, paragraph, subparagraph, clause or provision so adjudged and the remainder of the Ordinance shall be deemed valid and effective.

FOURTH: Repeal of Prior Ordinances

Ordinances or parts of Ordinances inconsistent with the provisions of this Ordinance be and the same are hereby repealed to the extent of any such inconsistencies.

FIFTH: Effective Date

This Ordinance shall take effect after final passage and publication and as provided by law.

PUBLIC NOTICE is hereby given that the foregoing proposed Ordinance was introduced and read by title for the first time at a meeting of the Township Committee of the Township of Maplewood, held on January 19, 2010, and that Committee met again on February 2, 2010, at 7:30 p.m. at the Municipal Building, 574 Valley Street, Maplewood, New Jersey, at which time and place the Committee proceeded to consider the said Ordinance on second reading and final passage.
