**AN ORDINANCE  
TO AMEND  
CHAPTER 257  
OF THE CODE OF THE TOWNSHIP OF MAPLEWOOD  
ENTITLED  
"Vehicles and Traffic"**

*"Interpretive Statement"*

*This ordinance will change certain time limit parking and permit parking on Dunnell Road and will provide parking for Low Speed Vehicles on Dunnell Road.*

**WHEREAS**, the Township Engineering Department has reviewed various parking ordinances of the Township of Maplewood ("Township"); and

**WHEREAS**, the Township Engineering Department has recommended the following changes:

**NOW, THEREFORE, BE IT ORDAINED**, by the Township Committee of the Township of Maplewood, County of Essex, State of New Jersey that Chapter 257 of the Code of the Township of Maplewood entitled "Vehicles and Traffic" be amended as follows:

**FIRST: Section 257-53 - Schedule XVII: Time Limit Parking**  
Shall be deleted.

**SECOND: Section 257-61 - Schedule XXV: Permit Parking**  
**Shall be deleted.**

**THIRD: The following Section**  
**shall be added.**

Low Speed Vehicle Only ("LSV") Permit Parking:

Dunnell Road	East	All Times	From a point 593 feet north of Baker St. to a point 36 feet north thereof.

**FOURTH: Severability**

If any section, paragraph, subparagraph, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the specific section, paragraph, subparagraph, clause or provision so adjudged and the remainder of the Ordinance shall be deemed valid and effective.

**FIFTH: Repeal of Prior Ordinances**

Ordinances or parts of Ordinances inconsistent with the provisions of this Ordinance be and the same are hereby repealed to the extent of any such inconsistencies.

**SIXTH: Effective Date**

This Ordinance shall take effect after final passage and publication and as provided by law.

**PUBLIC NOTICE** is hereby given that the foregoing proposed Ordinance was introduced and read by title for the first time at a meeting of the Township Committee of the Township of Maplewood, held on May 19, 2009, and that Committee met again on June 3, 2009, at 7:30 p.m. at the Municipal Building, 574 Valley Street, Maplewood, New Jersey, at which time and place the Committee proceeded to consider the said Ordinance on second reading and final passage.
