An ordinance to amend ordinance 2560-08 to provide classification of employment positions within the Township of Maplewood and to establish salary ranges for employees of the Township of Maplewood

NOW, THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Maplewood, County of Essex, State of New Jersey as follows:

SECTION I: The following positions shall be classified:

**SECTION IV:** If any section, paragraph, subparagraph, clause or provision of the ordinance shall be judged invalid, such adjudication shall apply only to the specific paragraph, subparagraph, clause or provision so adjudged and the remainder of the ordinance shall be deemed valid and effective.

**SECTION V.** All ordinances or parts of ordinances not consistent with the provisions of this ordinance are hereby repealed.

**SECTION VI:** This ordinance shall take effect after final passage and publication in accordance with law.
