AN ORDINANCE  
TO AMEND  
CHAPTER 257  
OF THE CODE OF THE TOWNSHIP OF MAPLEWOOD  
ENTITLED  
"Vehicles and Traffic"

*"Interpretive Statement"*

*This ordinance will change certain parking regulations on Dunnell Road, Orchard Road and Boyden Avenue.*

WHEREAS, the Maplewood Transportation Committee from time to time makes recommendations to the Maplewood Township Committee with regard to parking changes; and

WHEREAS, the Maplewood Township Planning and Engineering Committee has reviewed the changes proposed by the Maplewood Transportation Committee and has recommended implementation of the proposed changes.

NOW, THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Maplewood, County of Essex, State of New Jersey that Chapter 257 of the Code of the Township of Maplewood entitled "Vehicles and Traffic" be amended as follows:

FIRST:

Section 257-50                      Schedule XIV:                      No Stopping or Standing

- (1) DELETE THE FOLLOWING:  
Name of Street:                      Jacoby Street  
Side of Street :                                      East  
Location:                                      From a point 150 feet north of Boyden Avenue to a point  
150 south of Boyden Avenue.
- (2) ADD THE FOLLOWING:  
Name of Street:                      Jacoby Street  
Side of Street:                                      East

Location: From a point 105 feet north of Boyden Avenue to a point 150 feet south of Boyden Avenue.

- (3) ADD THE FOLLOWING:  
Name of Street: Orchard Road  
Side of Street: East  
Location: From 87 feet south of Parker Avenue to a point 51 feet south thereof

**SECOND:**

**Section 257-53                      Schedule XVII:      Time Limit Parking**

- (4) DELETE THE FOLLOWING:  
Name of Street: Dunnell Road  
Side of Street: West  
Time Limit: 20 minutes  
Hours/Days: 8:00 a.m. to 5:00 p.m./All  
Location: From a point 360 feet south of Oakland Road to a point 450 south thereof.

**THIRD:**

**Section 257-61                      Schedule XVI:      Permit Parking**

- (5) ADD THE FOLLOWING:  
Name of Street      Dunnell Road  
Side of Street              West  
Hours/Days:              6:00 a.m. to 9:00 a.m.  
Monday to Friday  
Except Holidays  
Location                      From a point 360 feet south of Oakland Road to a point 455 feet south thereof.

**FOURTH:      Severability**

If any section, paragraph, subparagraph, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the specific section, paragraph, subparagraph, clause or provision so adjudged and the remainder of the Ordinance shall be deemed valid and effective.

**FIFTH:      Repeal of Prior Ordinances**

Ordinances or parts of Ordinances inconsistent with the provisions of this Ordinance be and the same are hereby repealed to the extent of any such inconsistencies.

**SIXTH:      Effective Date**

This Ordinance shall take effect after final passage and publication and as provided by law.

**PUBLIC NOTICE** is hereby given that the foregoing proposed Ordinance was introduced and read by title for the first time at a meeting of the Township Committee of the Township of Maplewood, held on March 3, 2009, and that Committee met again on March 17, 2009, at 7:30 p.m. at the Municipal Building, 574 Valley Street, Maplewood, New Jersey, at which time and place the Committee proceeded to consider the said Ordinance on second reading and final passage.
