## ORDINANCE

#2233-03

### AN ORDINANCE TO SET PERMIT PARKING FEES AND JITNEYS FEES

*"Interpretive Statement"*

*This Ordinance increases the fees for commuter parking, jitney use and combined parking and jitney use.*

BE IT ORDAINED, by the Township Committee of the Township of Maplewood, County of Essex, State of New Jersey, as follows:

**FIRST:** CHAPTER 155 of the Code of the Township of Maplewood entitled "Jitneys" shall be amended as follows:

Section 155-1

Pass or Ticket required. Cost of Pass

- a. No person shall ride upon the Maplewood Jitney Bus unless they exhibit a current Jitney bus pass or provide the driver with a daily ticket. The cost of the pass on an annual basis (January 1 to December 31), shall be sixty-five (\$65.00) dollars. Any pass issued after June 30 of the pass year shall cost one half (2) of the regular pass fee.
- b. A Township Resident may purchase a combined Jitney Bus Pass and Parking Permit (See Section 257-33). The cost of the combined pass/permit on an annual basis (January 1 through December 31), shall be one hundred fifty-five (\$155.00) dollars. Any pass/permit issued after June 30 of the pass/permit year shall cost one half(2) of the regular pass/permit fee.

**SECOND:** CHAPTER 257 of the Code of the Township of Maplewood shall be amended as follows:

Section 257-33: Parking Restricted.

- a. No person shall park a vehicle between the hours specified and on the days specified upon any of the streets or parts of streets described in Schedule XXV (Section 257-61) attached to and made a part of this Chapter, unless the vehicle shall bear a valid permit.

A Township resident may purchase a permit. The cost of a permit on an annual basis (January 1 through December 31), shall be one hundred thirty-five (\$135.00) dollars. Any permit issued after June 30 of the permit year shall cost one half (2) of the regular permit fee.

- b. A Township Resident may purchase a combined Jitney Bus Pass (See Section 155-1) and Parking Permit. The cost of a combined pass/permit on an annual basis (January 1 through December 31), shall be one hundred fifty-five (\$155.00) dollars. Any pass/permit issued after June 30 of the pass/permit year shall cost one half (2) of the regular pass/permit fee.

**THIRD:** If any section, paragraph, subparagraph, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the specific section, paragraph, subparagraph, clause or provision so adjudged and the remainder of the Ordinance shall be deemed valid and effective.

**FOURTH:** All Ordinances or parts of Ordinances inconsistent with the provisions of this Ordinance be and the same are hereby repealed to the extent of any such inconsistencies.

**FIFTH:** This Ordinance shall take effect after final passage and publication according to law.

**PUBLIC NOTICE** is hereby given that the foregoing proposed Ordinance was introduced and read by title for the first time at a meeting of the Township Committee of the Township of Maplewood, held on November 17, 2003 and that Committee met again on December 2, 2003, at 8:00 p.m. at the Municipal Building, 574 Valley Street, Maplewood, New Jersey, at which time and place the Committee proceeded to consider the said Ordinance on second reading and final passage.
